

**Last Will and Testament of

**I.**

I hereby direct and order that all just debts for which proper claims are filed against my estate, and the expenses of my last illness and funeral, be paid by my Executrix as soon after my death as is practicable, provided, however, that this direction shall not authorize any creditor to require payment of any debt or obligation prior to its normal or contractual maturity.

**IV.**

I direct that all estate expenses, inheritance and other taxes, and interest or penalties thereon imposed by reason of my death, whether or not attributable to property passing under this Will, and whether or not the same would otherwise be payable by my estate or by a recipient of such property, be paid and discharged by my Executrix out of the residue of my estate with no right of reimbursement for the recipients named in the residuary clause of this Will.

**V.**

I give, devise and bequeath unto my daughter, \_\_\_\_\_, all of the rest, residue and reminder of my estate, whether real or personal, and wheresoever situated. I expect she will clean out my apartment, take whatever she wants, and give the rest away to whoever she would like.

**VI.**

I hereby nominate and appoint my daughter, \_\_\_\_\_, as Executrix of this, my Last Will and Testament, to act without bond. My Executrix shall be entitled to reimbursement of all her expenses, and a commission as set forth in the New York State Surrogate's Procedure Act.

**VII.**

Except to the extent otherwise required by law, I direct that my estate be settled without the intervention of any court, that my Executrix settle my estate in such a manner as shall seem best and most conveniently to her, and that I hereby empower my executor to mortgage, lease, sell, exchange and convey the personal and real property of my estate without an order of court for that purpose and without notice, approval or confirmation and in all other respects to administer and settle my estate without the intervention of the court.
